

DEFINITIONS

Academic Programme shall mean a programme of courses and/or any other component leading to completion of any of the online courses available on growatpace.com.

Student/Learner shall mean a candidate admitted to the online courses available on growatpace.com.

Platform shall mean the courses marketed and run by growatpace.com

ACADEMIC PROGRAMME CONTENT, DELIVERY & DURATION

The courses shall comprise of textual/video materials/exams and/or other components as decided by the platform.

The content of the course shall be delivered online through a secure learning platform, and will be available for period that the course is running from the date on which the access will be provided to the student. Beyond this time, a student may retain the content of the course for further use after the completion of the stipulated time by paying a renewal fees to the platform on an annual basis and as specified from time to time or any such means as decided from time to time. Notwithstanding anything in this Terms and Conditions, the student will pay any re-examination fee, course fee or any other fee as stipulated by the platform, failing which their access to the course can be suspended or permanently terminated. In some premium courses extended access is promised. Such persons will be given access to the course for at least two (2) years, which upon request can be extended by paying a renewal fees to the platform on an annual basis and as specified from time to time or any such means as decided from time to time.

Unless specifically allowed, the online content may not be available for download or in hard printed copy, although you may keep your browser tab open for accessing it offline. Some of the material may be made available for a price to be declared if there are enough takers for the same.
